Meet Jacob Hudson By Leah Pittman

Jacob Hudson is a 14 year old freshman at Mariemont High School and like most kids his age he loves to play video games, basketball and Tae Kwon Do, which he is a red belt at the Tigers Lair Martial Arts. Like most kids, school is not his favorite place to be but he does like to hang with his friends and his favorite subjects are Computer Program and Latin. UNLIKE most kids Jacob's age he is a Type 1 diabetic.

Jacob joins the more than 29 million Americans living with diabetes. According to the American Diabetes Association website, www.diabetes.org, in type 1 diabetes, the body does not produce insulin. Insulin is a hormone



that is needed to convert sugar, starches and other food into energy needed for daily life. With the help of insulin therapy and other treatments, even young children can learn to manage their condition and live long, healthy lives. Diabetes is a problem with your body that causes blood glucose (sugar) levels to rise higher than normal. This is also called hyperglycemia. Type 2 diabetes is the most common form of diabetes. If you have type 2 diabetes your body does not use insulin properly. This is called insulin resistance. At first, your pancreas makes extra insulin to make up for it. But, over time it isn't able to keep up and can't make enough insulin to keep your blood glucose at normal levels.

Jacob was diagnosed shortly after his 13th birthday in April of 2013. Since then he has had to learn to live life a little differently than most of us. Jacob now has to count carbs before and after he eats, he has to be aware of where his glucose levels stand and know how to adjust accordingly by either drinking water or taking a glucose tab. He can't ride his bike or participate in activities without taking his kit with him and when he goes to Kings Island he has to check is blood several times as heat, adrenaline and dehydration can all affect his glucose levels. Jacob also has to educate his friends and family about his disease, so they too can help manage his care.

These are not the only things that have changed, people not understanding what diabetes is and how it affects the body is another hurdle Jacob has faced. Due to this misunderstanding by most of the general public Jacob has put efforts forth to educate and inform the public about Diabetes and how it affects him and his family. This past June, Jacob got to meet Nascar Nationwide Driver Ryan Reed, through Ryan's Mission Drive to Stop Diabetes and learned that Ryan too was trying to educate the public on the growing epidemic of diabetes.

In 2014 the CDC issued a report stating that over 29 million Americans living in the United States had either Type 1, Type 2 or gestational diabetes. Ryan learned that 50% of the Nascar population was afflicted with Type 2 diabetes and made it his mission to begin to educate and inform the Nascar fans about diabetes. Rvan partnered with the

American Diabetes Association to spread the word and a bring awareness. The Drive to Stop Diabetes program made its way to the Kentucky Speedway in June and Jacob, his mother and father were the first to volunteer. They felt that this was a way that they could give back, little did they know that this event would be the catapult into the fast lane.

Before Jacob was diagnosed he did not really know anything at all about diabetes. Now he knows the difference between the three types and why it is important that everyone be aware of the signs and symptoms. Jacob now volunteers for the American Diabetes Association as a Youth Ambassador and has participated in the Tour de Cure. He was able to participate in diabetes camp this year and has already formed a team for Step Out Walk to Stop Diabetes. Jacob would like everyone to take a risk test which can be found at http://www.diabetes.org/are-you-at-risk/diabetes-risk-test/?loc=atriskslabnav and join him at Step Out Walk to Stop Diabetes in November 1, 2014 at Great American Ball Park. We will prepare your Fairfax Return free of charge. Individuals need to bring all 2013 W-2's, 1099 Misc. forms and/or other income statements to our Tax Office. If you were self- employed or had rental income during 2013, bring your completed Federal Schedule C or E. *If you misplaced your 2013 W-2's, etc. contact your employer or tax preparer to get new copies. "Businesses need to attach a copy of their Federal Return."

<u>ALL RESIDENTS 18 YEARS OR OLDER MUST FILE</u> a tax return with the Village of Fairfax, even if no tax is due. This includes those who rent. Taxes are based on an individual's earned income. Owners of rental property must also file a return.

Received a notice that the 2013 Tax Return you filed was incomplete? You need to reply promptly. Any incomplete Tax Return is considered "unfiled" and after 30 days of the 1st notice is subject to legal action and late filing fees. If you receive a correction notice stating additional tax due, you must submit tax due and "signed copy of the corrected 2013 Tax Return" by the due date in your notice. Other corrections also require "signed copy" of the corrected 2013 Return.

POLICY FOR LATE FILING FEE and LATE PAYMENT OF TAX

Late filing fee of \$15.00 to \$30.00 charged even if no tax is due.

Past due Tax, penalty 1% per month and/or interest 1% per month on balance due.

1st time filers are exempt from late filing fee, but still pay penalty and interest. (However, if a taxpayer does not respond to our letters, they still can be subject to late filing fee, penalty and/or interest, and possible legal action.)






BOARD APPROVES PROPOSED CUTS IF SCHOOL LEVY DOES NOT PASS

Stating that they are hoping for the best on Election Day but that they must prepare for the worst-case scenario, the Mariemont Board of Education approved a list of \$1.9 million in cuts that will be phased in if the November 4 levy does not pass.

"None of us wants to implement what appears on this list and it is not what we hope for our future and what earned us the #1 rating in the entire area from *Cincy Magazine*, stated Ken White, board president. "Regardless, we believe in open and honest communication with our public about what is at stake and that's what this is about."

Dee Walter, board vice president agreed. "Since the last levy our schools have seen significant losses in funding from the state and have enacted reductions to offset those losses. In fact, we did all that while stretching the last levy to last one year beyond what we promised voters. Now, this levy represents the lowest millage rate that will protect what we have."

During the evening's presentation, Tom Golinar, district treasurer, along with Superintendent Steven Estepp noted that the \$1.9 million in cuts is based upon what the district knows today regarding funding. In other words, that cut amount could increase if the state of Ohio enacts further, unforeseen cuts to Mariemont City Schools, or if they implement any unfunded mandates over the next several years.

In arriving at the list, Superintendent Estepp also noted that while efforts were made to protect students and programs, the reality is that district's budget is largely earmarked to the classroom already so that it is not

possible to spare what happens in the schools each day. "The fact is that cuts hurt our schools and without a doubt our schools would look very different if we had to implement these cuts," stated Steven Estepp, superintendent. "It is clear that much is at stake for the schools that we care about and this helps inform residents before they vote in the November election."

Listed below are the board-approved \$1.9 million in cuts that will occur over the next two years if the Tuesday, November 4 issue does not pass.

Phase 1 (Implemented during the 2015/16 school year – \$900,000 cut)

- Eliminate classroom instructional aides in elementary classrooms
- Reduce elementary art, general music and PE and implement the PE waiver for MHS students
- ${\boldsymbol{\cdot}}$ Eliminate the district College & Career Planning Center counseling position
- Reduce media center hours in all schools
- Eliminate one administrative position
- No base pay increases for district staff
- Reduce transportation to state minimum Increase pay-to-play fees & caps

Phase 2 (Implemented during the 2016/17 school year - \$1 million cut)

- Eliminate six teaching positions across all grade levels
- ullet Eliminate three support positions
- Eliminate one administrative position
- Eliminate all fields trips (including Camp Kern)
- Reduce technology integration specialists
- No base pay increases for district staff
