# TED SHANNON MEMORIAL GOLF OUTING SEPTEMBER 27, 2020

The Village of Fairfax, along with the Mariemont Kiwanis organization, will host the annual Ted Shannon Memorial Golf Outing on Sunday September 27, 2020. This event has been rescheduled from May. Golfing is an allowable outdoor activity and teams of 4 can be formed. Or, if you are a single golfer, you may still sign up and we can place you on a team. Cost is \$65 per player and includes 2 golf carts for your team of four. The event will be held at California Woods Golf course. Monies raised from the event will go to support Village recreation events as well as the Kiwanis scholarship program for graduating seniors of Mariemont High School. This scholarship has directly benefited many Fairfax residents over the years and the Village greatly appreciates the partnership we have made with such a worthwhile organization.

## 2020 RESIDENTIAL STREET PROGRAM

The JK Meurer Construction Company has been awarded the contract for the 2020 residential street construction project. Work was originally scheduled for early July; however, the project was delayed a bit due to ODOT work on Wooster Pike. The Fairfax project did not want to compete with traffic back-ups related to that project.

Streets included on the Fairfax project will have road and/or curb replacement and are as follows: Arrow Point Way, Eleanor Street, and the dead-end portion of High Street. The intersection of Wooster Road/Red Bank Road will also receive asphalt repairs and new striping. Notices to residents have been provided, but more specific notices will be given out by the contractor. If you are a resident on any of these streets, please be aware that no parking signs during construction will be posted. Please make plans now on where to store your vehicle if you cannot place it in a driveway.

# **COUNCIL UPDATES**

Council meets the third Monday of each month at 7:00 PM. The following is a summary of legislation passed at the over the last several months:

- Awarded the 2020 Residential Street Resurfacing Project to JK Meurer
- Approve an Energy Special Improvement District (ESID) for residential energy improvement projects
- Provide for the employment of legal counsel
- Amended section 70.32 of the Traffic Code prohibiting and providing penalties for driving under suspension
- Adopted resolution providing preliminary consent for approval of the Ohio Department of Transportation (ODOT) Project PID 112171: the implementation of various traffic signal upgrades along Wooster Pike.
- Adoption of the 2021 Budget

#### **SWIMMING POOL REGULATIONS**

Several residents have recently inquired about swimming pool regulations at private residences. The Fairfax Zoning Code (Chapter 4.4 (E) 1-4 dictates that any in-ground pool which is more than 24 inches in depth at any point OR greater than 150 SF in surface area shall erect and maintain an enclosure surrounding the pool area. (i.e. fencing) The exception is for pools with walls at least 48 inches high or above grade (i.e. above ground pools). No enclosure is required if the ladder to access the pool is removable and inaccessible to small children when not in use. Pool covers may be installed, but is not considered a substitute for an enclosure that may be required. Pools do require an inspection.
